ROAD TRAFFIC REGULATION ACT 1984

VARIOUS ROADS, FINCHAMPSTEAD AND SANDHURST

**(YATELEY 10K SERIES RACE) (TEMPORARY PROHIBITION OF DRIVING) (No.2)
ORDER 2025**

WHEREAS the Wokingham Borough Council also acting with delegated powers granted by Bracknell Forest Council, as Traffic Authority, is satisfied that traffic on the roads described in Articles 3 to 7 of this Order in Finchampstead and Sandhurst should be prohibited to facilitate the holding of the 'Yateley 10k Series Race' on the said roads.

AND WHEREAS pursuant to Section 16A (8) of the Road Traffic Regulation Act 1984 ("the Act") the Council has had regard to the safety and convenience of alternative routes suitable for the traffic affected by this Order and has concluded this Order will provide for a series of ongoing 'rolling' closures.

AND WHEREAS Lower Sandhurst Road, Sandhurst and Mill Lane, Sandhurst is within Bracknell Forest Council and that council has given consent, in accordance with section 16A (7) of the Act, to Wokingham Borough Council making this Order.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Act and all other enabling powers HEREBY MAKES the following Order:

1. This Order shall come into operation on the 1st July 2025 and shall be cited as the WOKINGHAM BOROUGH COUNCIL (VARIOUS ROADS, Finchampstead and Sandhurst) (YATELEY 10K SERIES RACE) (TEMPORARY PROHIBITION OF DRIVING) No.2 ORDER 2025
2. This Order shall come into operation on the 1st July 2025 and shall lapse on 14th August 2025 and shall only be enforceable on 2nd July and 13th August 2025 in respect of the relevant sections of the roads described in Articles 3 to 7 hereof when signs conforming to the requirements of Section 64 of the Act are lawfully displayed in the lengths of those roads respectively referred to in Articles 3 to 7 hereof.
3. Save as provided in Articles 8 and 9 hereof, no person shall cause or permit any vehicle to proceed along B3016 Longwater Road, Finchampstead between its junctions with the Wokingham Borough Boundary and Cricket Hill.
4. Save as provided in Articles 8 and 9 hereof, no person shall cause or permit any vehicle to proceed along Cricket Hill, Finchampstead for its entirety.
5. Save as provided in Articles 8 and 9 hereof, no person shall cause or permit any vehicle to proceed along Lower Sandhurst Road, Finchampstead for its entirety.
6. Save as provided in Articles 8 and 9 hereof, no person shall cause or permit any vehicle to proceed along Lower Sandhurst Road, Sandhurst for its entirety.

7. Save as provided in Articles 8 and 9 hereof, no person shall cause or permit any vehicle to proceed along Mill Lane, Sandhurst for its entirety.
8. Nothing in Articles 3 to 7 hereof shall apply to any vehicle proceeding along the relevant roads for any purpose in connection with the holding of or participating in the 'Yateley 10k Series Races' or to any vehicle being used in the service of Police, Fire or Ambulance services or proceeding at the direction of a police constable in uniform or for access to properties or businesses only accessible from the said roads.
9. The restrictions contained in Articles 3 to 7 hereof shall only have effect in respect of each road referred to in those Articles at such times as signs required by the Traffic Signs Regulations and General Directions 2016 (as amended) are lawfully displayed in the respective lengths of the roads described therein.
10. The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
